



Q: What does Governor David Ige's Interisland Travel Order (Fourth Supplementary Emergency Proclamation) do?

A: Beginning **at 12:01 AM on April 1**, all interisland travelers will be subject to self-quarantine and self-monitoring for 14 days while away from their island of residence. Self-quarantine means travelers must remain in their hotel rooms or place of lodging, order food delivery, and not receive visitors.

Q: Is anyone exempt from this self-quarantine?

A: Yes. Persons who are traveling interisland for medical or healthcare reasons will not be subject to self-quarantine provided that they wear appropriate protective gear (e.g. a mask) and follow social distancing requirements during their stay. Certain workers, as described below, are also exempt from self-quarantine.

Q: Does the self-quarantine order apply if I am traveling interisland for work?

A: Yes. Only persons traveling between islands to "perform functions necessary to maintain continuity of the federal critical infrastructure sectors" as identified in the Governor's Third Supplementary Proclamation "may break quarantine to perform necessary functions."

Q: What counts as work related to critical infrastructure?

A: Critical infrastructure includes work and tasks necessary to ensure the continued operation of facilities related to healthcare, first responders, food production and distribution, financial services, communications, certain types of manufacturing, and others as listed by the federal government. A full list can be found at www.cisa.gov. The Director of the Hawaii Emergency Management Agency may also identify other types of work as necessary for critical infrastructure.

Q: Who can I contact to see whether my work qualifies as work related to critical infrastructure?

A: Please email covidexemption@hawaii.gov to see whether your work qualifies as work related to critical infrastructure.

Q: Does this apply to travel between islands within the same county? For example, would it apply if I flew from Molokai to Maui?

A: Yes. This order applies to all travel between islands, including those within the same county. In the above example, the order *does* apply.

Q: What am I required to do before traveling interisland?

A: Before traveling interisland, you are **required to complete an Interisland Declaration Form** that asks for your name, contact information, destination, location of lodging, purpose of visit, and duration of visit. This form will be **turned in prior** to going through TSA screening.

Q: What restrictions will I be subjected to after arriving on the island I am traveling to?

A: If you are exempt from the interisland self-quarantine order and are on the island to perform work related to critical infrastructure, you will be required to wear a mask while performing your work. When you are not working, you will be required to self-quarantine at your place of lodging (i.e. hotel) until you either return to your island of residence or the 14-day period has elapsed. All other persons will be required to self-quarantine for 14 days.

Q: Am I allowed to go shopping or have guests while self-quarantining?

A: No. You are prohibited from visiting public places (e.g. stores and parks) and are not allowed to have visitors at your quarantine location.

Q: Am I required to remain on the island that I travel to for the full 14 days if my trip was planned to be shorter than that?

A: No. You will be allowed to leave the island you are traveling to before the 14-day self-quarantine has elapsed.

Q: When I return to my island of residence, do I have to self-quarantine for 14 days?

A: No. Once you return to your island of residence, you do not have to self-quarantine for 14 days. However, you must wear appropriate protective gear (e.g. a mask) as well as observe social distancing and other guidelines that apply in your county.

Q: Who is responsible for enforcing the self-quarantine for interisland travelers?

A: County police departments are responsible for enforcing self-quarantine orders.

Q: Who can I contact if I know someone is violating the self-quarantine order?

A: You can contact the Hawaii Emergency Management Agency at (808) 733-4300 or your local police department at 911.

Q: Does this only apply to travel on commercial airlines?

A: No. It applies to any method of travel between islands, including travel done on private aircraft or boats.

Q: Are there penalties for violating the order?

A: Yes. The order has the force and effect of law. Intentionally or knowingly violating the order is a misdemeanor. Upon conviction, a person could face a fine of up to \$5,000, up to one year in jail, or both.
